### **John Ross**

John was a proud father and a member of the gun culture. A true believer in individual liberty, he was a tireless advocate for gun rights and one of the main drivers of the concealed-carry movement in Missouri. Over 30 years ago, when no one believed we would ever pass a right-to-carry law, he hosted a meeting of legislators and gun-rights organizations to insist we do just that. He hired a lobbyist, found a state representative to introduce it, and initiated the fight. For almost 15 years, it was the focus of his efforts. Along the way, he authored *Unintended Consequences*, a novel about the gun culture he loved that sold over 100,000 copies, and the first-of-its-kind comparative study, *Self Defense Laws and Violent Crime Rates*.

An incurable optimist, he was a multi-talented person who mastered everything he put his mind to. He built race cars and motorcycles, was a pilot, a machine gun dealer, and an expert in everything firearm related. Always a revolver enthusiast, he designed and had Smith & Wesson build a run of his own version of their .500 Magnum revolver. Whether it was designing and building a gun, longrange rifle shooting, reloading, cartridge development, bowling-pin matches, or big-game hunting, the shooting sports were his #1 passion.

Those who knew him never heard him speak a cross word, and anyone lucky enough to call him a friend will tell you: A chapter in Missouri history has come to a sad end with his passing.

# 25 States Now Have Constitutional Carry

So far this year four states — Alabama, Ohio, Indiana and Georgia — have passed constitutional carry or permitless carry laws, making them the 22nd, 23rd, 24th and 25th states to do so. Fifty percent of U.S. states have passed laws permitting constitutional carry or permitless carry in the last two decades.

### What Is Constitutional Carry?

When a state does not prohibit individuals who can legally possess a firearm from carrying handguns it is called constitutional carry. When a state allows constitutional carry but individuals must meet certain qualifications to legally carry, it is referred to as permitless carry. For instance, Tennessee does not allow an individual to carry without a permit if he or she has received a DUI in the last five years or two or more in the last 10 years.

Constitutional carry or permitless carry has been on the rise in the last 20 years. Alaska was the first state to pass it in 2003. This was followed by Arizona and Wyoming (2010); Kansas, Maine, and Mississippi (2015); Idaho, Missouri, and West Virginia (2016); New Hampshire and North Dakota (2017); Arkansas (2018); Kentucky, Oklahoma and South Dakota (2019); Iowa, Tennessee, Texas, Montana, Utah, and Wyoming (2021); and Alabama, Ohio, Indiana and Georgia (2022). Vermont has been a constitutional carry state since 1793, with it written in its constitution. Nineteen of the 25 states (or 76 percent) have adopted constitutional carry or permitless carry in the last six years.

## Which States Allow Constitutional Concealed Carry?

There are currently 25 constitutional carry or permitless carry states. These states include:

It is a Good Day for Liberty.

In 1939, the Soviet Union invaded Finland. It is said that a Finnish border guard gazed at the invading horde and said, "So many Russians, where will we bury them all?" Today, the Ukraine has the same problem.

Nearly 20 years ago, a client was stopped for speeding. He had one of the early concealed carry licenses, and this led to the question. "Did he have a gun?" He had three guns, and the officer announced that his license only allowed him to have one gun. This was not true, but the officer did not know it. The officer gave him a speeding ticket, seized the three guns, and sent him on his way. The client asked for his guns back the next day, and the department refused to discuss it. It had no right to take the guns and no right to keep the guns. It just refused to discuss giving them back. My client sued in federal court for the return of his property and money damages. The result was satisfactory.

Another client called the police when her boyfriend threatened her with a gun. The police arrested him and seized his gun; and her gun, which was not involved in the case. They refused to discuss returning the gun. Nasty legal threats resolved the problem.

Missouri law at 571.095 requires guns to be returned to the legal owner at the end of a case, unless the owner has been convicted of a felony. I have seen many cases in which this requirement is ignored, there is no penalty. Prosecutor offices have told me it is their policy not to return guns. I'm sure this is a perfectly adorable policy written in cute type. However, it is unconstitutional to deprive persons of property without due

Some say that since our guns are concealed, the police will never know. I have read cases from over one hundred years of police discovering concealed weapons. New York used to have a police section devoted to finding people on the street carrying guns. There are specific indicators of carrying a concealed weapon. A jacket that sags to one side, the carrier touches and adjusts the gun. These may indicated other, unrelated, matters; which is why the group was disbanded. Statistically, it must uncover a certain number of concealed weapons. This is why these indicators live on in police training.

At the Oscars ceremony, comedian Chris Rock made a joke concerning Jada Smith. Her husband. Will Smith. thought this minor joke was an insult and rose to defend his wife. This is admirable, if excessive in the execution. He slapped Chris Rock. He then returned to his seat, and there were no immediate consequences. In the aftermath, this slap became a major news story. Some idiot talking heads said that Mr. Smith was not arrested because it was only a slap and that if it had been a punch it would have been assault. I wish that people who did not know what they were talking about would stop talking. Assault is defined, generally, as an attempt to commit a battery. Battery is defined, generally, as harmful or offensive touching. The Bible says that if someone slaps you on one cheek; offer him the other (because a slap is only an insult). Much of our law is Biblically based, but we are not a theocracy. A slap is an insult, which is offensive conduct. Mr. Smith could have been arrested for common-law assault and battery. This is a misdemeanor. Mr. Rock did not consider it to be worthy of a complaint. Is the slap bad behavior? Certainly. This is important only because it occurred between famous people, during a famous event and on national television.

Will Smith posted an apology saying that the slap had no place in a world of peace and love. I agree, but am alarmed that he thinks he is living in such a world.

A Rand Corporation analysis: of 27,900 studies which supported gun rights restrictions, only 123 used scientific methods. Even those few did not support restrictions. Remember this when confronted with the latest "study." When they use a small sample, manipulate definitions, use selective data and decide the desired result before gathering data, anything can be proven. There is a book, "How to Lie With Statistics" which everyone involved with our movement should read. It will help understand the tricks used by the usual suspects. It is commonly claimed that there is one school shooting a week. They come to this statistic by claiming any shooting in the vicinity of a school is a school shooting. The shooting could be between gangs or as part of a robbery and have nothing to do with a school, but it pads their statistics. We are often told that it is many times more likely to have a gun in the home kill a family member than kill an intruder. The first such study had many flaws. First, home intruders are seldom killed. They are repelled, captured, wounded, but seldom killed. The comparison is meaningless. Second, the families selected for the "study" were already in the system for one reason or another. They were not average families but families that had received official attention for one reason or another. Third, the sample included only a few hundred families. Extrapolating this sample to the entire country is invalid. Lastly, the gun used to kill a family member belonged to the family in only two instances. "How to Lie With Statistics" is a very slender but very important book.

A recent study claiming that guns in the home are more dangerous to the family than intruders announces that it found no defensive gun uses. All of us have read of defensive gun uses. Anyone doing a legitimate study could not help but find some defensive uses. Unless, of course, the study was designed to find an antigun result.

tion has not run an article on trapping in many years. Anyone with experience in this area should contact the newsletter editor

Everyone stop what you are doing. Check the expiration date of your license to carry. I will wait. There is a financial penalty for late renewals. If your license expires, it turns into a pumpkin. It is a federal crime to carry a gun through a school zone unless you have a license issued by the state the school is in. This should be a warning to people carrying under the permitless or constitutional law.

While you have your wallet open, you should also check to see when your driver's license expires.

Jimanez Arms in Arizona made a good quality low-cost handgun. It was driven into bankruptcy by a lawsuit filed by the City of Kansas City and Everytown for Gun Safety. The plaintiffs claimed the company dumped guns in Kansas City, selling them to illegal dealers, and this causes our crime rate. According to my information, an illegal dealer forged paperwork showing that he was the agent for a local gunshop. The company bought his story and shipped him guns. The company re-incorporated and was granted a license to manufacture handguns. Everytown for Gun Safety sued to revoke the new license and was successful. This creates a new legal front gun dealers must defend. The usual suspects can sue random gun shops. Few shops go through an ATF inspection without violations. Even if they successfully defeat the lawsuit against their license, it is another way to sue them into bankruptcy.

Twenty-five states now have Constitutional Carry. More states are on the verge of passing Constitutional Carry.

The Red Cross reports a severe blood shortage. There is always a blood shortage in the winter, and the pandemic and economic problems have made it worse. Give a little blood and wear your Second Amendment shirt or button when you do.

### May 2022

It is a Good Day for Liberty.

Everyone stop and give a round of applause to Carl Smart. He took over as master of ceremonies at Rally Day. Fighting a terrible cold, he did a magnificent job.

I've read "Case of a Lifetime" by a lawyer who spent twenty years doing post-conviction relief for a woman doing life in prison as an accessory to murder. She had accompanied a man who did the murder; there was no question of that. He did other murders as well. She let him use her car. She denied being with him on the day in question. An eyewitness placed her at the scene. Eyewitnesses are notoriously unreliable. His initial statement was that he saw her at a distance, fleetingly and could not describe her or her gender. By the time of trial, he was absolutely certain that she was at the scene. This happens. The lawyer describes her efforts to get the woman released. Ultimately she was successful. She returns again and again to the question that defense lawyers get, "How can you represent guilty people?" She gives the standard answers. I have represented guilty people. My view is the same as a great Clay County defense attorney. He represented a murderer in a nasty vicious killing. The prosecution had a mountain of evidence. I heard him asked why he defended the killer, and he replied, "I was just exercising my skills." Prosecutors practice their skills on guilty people, so do defense lawyers. When I have an innocent client, I will defend him with the skills I learned on the backs of guilty clients.

I'm doing Church Security legal classs. Loser psychopaths attack churches because they have a grudge against religion or a person in the church. Mostly they target churches because they are perceived to be soft targets. These cowardly scum want to run up a large death toll and become famous. Many churches have formed security teams. I advise the organization of these teams and circumstances under which they can act. There must be some formal organization to demonstrate that they have the right to be on the property and armed. I advise the statement that should be made in the aftermath. There are insurance questions. Most insurance

policies do not cover acts of selfdefense. There are private groups that offer self-defense "insurance." It is not really insurance and not governed by the insurance commissioner. They are membership benefits. It is a complex field. It should not be, but it is.

I remember the incident in which Jesus expelled demons from a man; not personally, but it has been reliably reported. I am concerned that He sent the demons into a herd of pigs. This must have spoiled the meat. As a good Jewish boy, Jesus may not have been overly concerned. I hate to see bacon wasted. It does show that some sacrifices must be made.

The 9th Circuit Court of Appeals has ruled that California cannot deny 18 to 21 year olds the right to buy rifles and shotguns. This is good, but not great. What usually happens in the 9th Circuit is that the case is re-heard by the entire court and the decision reversed. Still, every little bit helps.

Russia invaded the Ukraine believing it would be over in 72 hours. Seventy-two days later they were retreating. Reports are that Mariupol has fallen, and the last holdouts in the steelworks have given up. Other reports say that the severely wounded have given up and there are still holdouts including the senior officers in the maze of tunnels under the steelworks. This teaches us that it is only necessary to hold out to the last possible second.

The Ukrainians have killed a dozen Russian generals. They were able to do so because the generals got on radio and telephone networks and did not use communications security measures that I learned as a Second Lieutenant (because the Russians were listening). This is a lesson for us because the usual suspects monitor our communications. Things said in jest become evidence that we are bloodthirsty monsters. An NRA field representative told me that she walked out of a legislative meeting reporting the results to her boss on her cell phone. Then she discovered that one of the opposition was following her and listening to everything that she said.

The Russians have been employing old equipment in the current war, stuff that doesn't use the computer chips they can no longer get. I have even seen reports that Russian soldiers have been given 1891 Mosin Nagent rifles left over from WW II. I find this difficult to believe. They may have brought out sniper rifles based on the old rifle of course.

There have been many reports of Ukrainian civilians obtaining weapons to resist the Russians. I have not seen reports of these civilians in action. They have been reported as manning security positions to guard against sabotage. This releases soldiers for other duties. I look forward to future histories.

A racist scum murdered people in a New York state grocery store. He left behind a screed in which he declared that he selected the New York state location because the state's restrictive gun laws made it unlikely that someone would shoot back. In the event, a security guard shot back. The scum was wearing body armor. The impact may have distracted the scum and saved some lives, but the guard was killed. The scum deliberately used the same model of AR 15 rifle used in the Sandy Hook massacre. He hoped to increase demands for gun restrictions. It seems

the scum got his wish.

The scum-sucking racist surrendered when police arrive. This is rare. These are normally suicide missions. The scum-sucking racist wore body armor. We have to work on our head shots. Of course, calling him a scum-sucking racist implies there is some other kind of racist. There is not.

The Missouri legislature ended its session a day early, a very rare occurrence. It also ended without taking up our bill to reduce the number of gunfree zones and other provisions. The bill was delayed going through the session because one provision ended sales tax on guns and ammunition. This required it to go through the finance committee. Trying for that extra bit of perfection may have cost us the bill.

The usual suspects claim our bill failed because they showed up. They did show up and made the usual arguments. The difference this year was the hatred they showed for us and our rights. I do not suggest that we respond in kind, quite the contrary. I suggest that we must show up. Our legislators may not, in many

cases, be very smart, but they can count.

The conference has always been highly informative and gives away piles of books and printed materials.

The Red Cross reports a severe blood shortage. There is always a blood shortage in the winter and the pandemic and economic problems have made it worse. Give a little blood and wear your Second Amendment shirt or button when you do.

In the words of two great time travelers, "Be excellent to each other!"

### **FINAL RULING BY ATF, APR 2022**

**Title:** Definition of "Frame or Receiver" and Identification of Firearms

**Action:** Final Rule

Purpose: The Department of Justice ("Department") is amending Bureau of Alcohol. Tobacco. Firearms and Explosives ("ATF") regulations to remove and replace the regulatory definitions of "firearm frame or receiver" and "frame or receiver" because the current regulations fail to capture the full meaning of those terms. The Department is also amending ATF's definitions of "firearm" and "gunsmith" to clarify the meaning of those terms, and to provide definitions of terms such as "complete weapon," "complete muffler or silencer device," "multi-piece frame or receiver," "privately made firearm," and "readily" for purposes of clarity given advancements in firearms technology. Further, the Department is amending ATF's regulations on marking and recordkeeping that are necessary to implement these new or amended definitions.

# FN 502 TACTICAL RECALL

FN has become aware of a potential safety issue with certain FN 502 Tactical pistols that were previously the subject of FN's January 27, 2022 Safety Bulletin.

The original concern involved a missing manual safety lock lever in a small number of FN 502 Tactical pistols that would allow the discharge of the pistol when the trigger is pulled with the manual safety in the SAFE position. While investigating this issue with Umarex, the supplier of the FN 502 Tactical, we encountered a separate concern with proper installation of the manual safety lock lever. Consequently, if forced by multiple pulls of the trigger in succession, or if the pistol is jarred, an unintended firing may happen when the manual safety is in the SAFE position.

Because the safety of our customers is our primary concern, FN is voluntarily issuing a recall to address this newly discovered issue involving the safety and advising all owners of the FN 502 Tactical to suspend use of their pistol and return the pistol to FN for repair or replacement in accordance with the recall instructions on the next page.

FN 502 Tactical pistols with a serial number lower than LR010300 are subject to this recall.

### RUGER SR22 SAFETY BULLETIN

A small number of SR22® pistols may have right and left frame inserts that are not properly secured together. In rare circumstances, this condition may render certain internal safety mechanisms ineffective, and the pistol has the potential to discharge upon decocking.

In rare instances, if the left and right frame inserts of Ruger SR22 pistols are not properly secured together, the firing pin blocker lifter and hammer block can move independently of each other, potentially rendering them ineffective. If this situation occurs, the pistol will intermittently exhibit a "slack" single-action trigger and has the potential to discharge if decocked over a live round. 

### MOSSBERG SA-410 SHOTGUN RECALL

Mossberg International, Inc. has recently discovered a potential safety issue with certain Mossberg Model SA-410 Shotguns which may lead to personal injury and/or damage to the shotgun.

Mossberg is voluntarily initiating a recall to protect the safety of its customers because if a user prematurely releases a shotshell while loading or unloading, the unretained shotshell could potentially contact the Bolt Lock Button inside the loading port and detonate.

### **MSSA NOTICE**

### By Laws Change

By Lee Koester

Shortly I will be making a proposal to reduce the size of the MSSA Board of Directors. This is a By Laws change.

#### **Points of interest:**

We currently have 18 directors. Six members are elected to the board of directors each year to serve a 3-year term.

Our membership is down from past years, currently at 330 voting members. Associate and Junior members make up the remainder. That is a ratio of 18.33 members per board seat.

It is getting exceedingly hard to get more than 4 board members at any in-person meeting, and only about 8 for our online meeting, usually in January. We have had as few as 2 at some meetings. Quorum qualifications are met because Quorum is 1 officer and 1 additional member. We do not get much done but we do meet the criteria for a legal meeting.

It is getting harder to find enough bodies to fill open board slots. It's beginning to feel more like a Shanghai than an election.

Our officers are nominated from the existing board, and we have all been serving a long time. I personally have been Treasurer for over 23 years and Secretary for over 12 of that time. OK, so I can't quit.

My feeling is that we would be better served by reducing the number of board seats to 15.

This may give us a better turn out for meetings.

Reducing board seats will not happen overnight.

Existing seats will remain but will be reduced each year over the next 3 years.

#### **PROPOSAL**

I propose we reduce the number of Board seats to 15, with only 5 seats being reelected each year. The process of reduction will take three years to complete and will begin with the elections at the annual members meeting in 2023.


